**DAMAGE:** The user group will keep clean and care for pool, site and all equipment used and pay for any damages to (site/facility/lost/broken) camp property.

**SUPERVISION:** Pool requested: Lap Rec Each pool capacity is 105. Each pool in use requires a lifeguard attentive to his/her responsibilities at all times and located in positions from which he/she can continuously observe and readily assist participants. A lifeguard may guard up to 25 persons in the same pool. Group adults will assist with behavior management by enforcing rules and supervising youth in the changing rooms.

**CERTIFICATIONS:** All lifeguards must hold current certifications in ARC Lifeguard Training or equivalent and First Aid & CPR. When providing its own guards, the group agrees to ensure a ratio of 1:25 swimmers per pool. Name(s) of lifeguards: \_\_\_\_\_
